- A forum to increase awareness, knowledge and understanding of agri-environmental issues relevant to the agriculture industry.

OUR PURPOSE

Vision

Agri-environmental policies are balanced, support sustainable industry growth, and increase social acceptance.

Mission

To engage and build knowledge of partner organizations which enable AEPA to provide credible, proactive, and respected input to agri-environmental policy development processes.

WHAT WE DO

Strategic Priorities

- Engage in agri-environmental policy development processes including land-use, water, air and biodiversity.
- Provide timely policy input on innovations and emerging opportunities that will help the agriculture industry achieve environmental sustainability.
- Engage and build understanding with partners and stakeholders to enable the agriculture industry to be a credible partner in agri-environmental policy development processes.

2016-2017 was the 2nd year of the 2015-2018 AEPA Strategic Plan.

As in previous years, priority policy issues included topics related to LUF and water. However, with the Government of Alberta's (GOA's) increased focus on the Climate Leadership Plan, the topic became a higher priority for AEPA. Other topics included the Next Agricultural Policy Framework (NPF, the successor to Growing Forward 2), and social licence (agri-environmental aspects). There was also increased engagement and relationship building with partner organizations (including GOA) and external stakeholders.

In regards to LUF, with the delay of regional planning processes, there was an opportunity for AEPA to renew consensus land-use planning key messages, and increase knowledge and understanding of related topics, including ecosystem services. Increased engagement with stakeholders, such as the Alberta Land Institute and Alberta Innovates, was also important.

On the issue of water, AEPA and partner organizations were invited to participate in the North American Waterfowl Management Plan's (NAWMP's) Wetland Stewardship and Agriculture Working Group. The purpose of the working group was to address challenges and find opportunities for agriculture to successfully implement Alberta's Wetland Policy. There was also opportunity to better understand other relevant topics such as drainage.

On the Climate Leadership Plan file, AEPA provided a submission with consensus input to the Climate Technology Task Force, who provided advice and recommendations to GOA. AEPA was able to engage in direct conversation with the Deputy Minister from the Alberta Climate Change Office.

To further build knowledge on issues related to water and climate change, AEPA hosted a tour of ALUS Canada and Ducks Unlimited Canada project sites in the County of Vermilion River. The day also included a tour of Lakeland College's Centre for Sustainable Innovation.

As AEPA looks towards 2017-2018, engagement in LUF and water related policy development processes will continue when opportunities arise. This includes responding to regional planning documents when released and participating in stakeholder engagement sessions. AEPA will also monitor progress in work related to ecosystem services and maintain its engagement in the implementation of the Wetland Policy.

AEPA will continue its role in providing input into policy development related to climate change, agri-environmental aspects of social licence, development of NPF, and other relevant issues as they emerge.

As AEPA enters the 3rd year of the 2015-2018 Strategic Plan, work will also focus on the development of the 2018-2021 Strategic Plan.

AEPA's communication with partners will occur through tools such as the website, e-newsletter, and monthly updates.
